

1. DATES

MICBasketball'20 celebrates its 4th edition from April 9th to April 12nd, 2020.

- a. Teams with type 1 (accommodation with organization) will have the deadline for arrival on Thursday April 9th.
- b. For teams that choose type 2 (without accommodation) the organization will fix a date before the start of the tournament for the delivery of accreditations, documentation and age control.
- c. The competition will start on Thursday April 9th, for all age classes, in the afternoon.

2. CATEGORIES

MALE

U18M Players born after 01.01.2002

U16M Players born after 01.01.2004

U14M Players born after 01.01.2006

FEMALE

U18W Players born after 01.01.2002

U16W Players born after 01.01.2004

U14W Players born after 01.01.2006

3. REGULATIONS

MICBasketball is played by FIBA rules. The modifications and exceptions to the aforementioned rules and regulations are reflected in the regulations of the MICBasketball'20 tournament.

4. COMPETITION SYSTEM

The competition system is composed by 3 phases.

a. CLASSIFICATION ROUND

Teams will be distributed in groups formed by 4 teams each.

In this round teams will play each other in a league group format.

b. FINAL ROUND

This round will be played by the best teams classified in the "Classification Round".

This round will be played according a Playoffs format, being eliminated of the round the looser team.

c. CONSOLATION ROUND

This round will be played by the teams not classified for the "Final Round"

This round will be played according a Playoffs format, being eliminated of the round the looser team.

*The competition system may vary according to the number of teams participating.

5. PLAYING FIELDS

All the tournament courts are made of parquet, except some of sintasol, near Lloret de Mar.

6. GAME TIME

4×10 minutes running time except for the last 1:00 minute of last period and last 1:00 minutes of overtime periods when stop time will be applied. On the first three periods during stop time the clock will only be stopped if the game is stopped by a referee. On the last period and overtimes



during stop time the clock will be stopped both if the game is stopped by a referee and if a team score.

7. AGE CONTROL AND PLAYERS NUMBER

Age control will be done upon arrival at the hotel and before the start of the first game. It can also be done without previous notice, during or after each game.

It is mandatory to keep in mind the documentation (ID, passport or federation card) of all the players in each of the matches played by the team.

There are no limitations on the maximum number of Players registered per team.

8. REGISTRATION

All the teams must follow the steps detailed in "Registration Rules" in the periods established by the organization.

- a. The team must register on the website **www.micbasketball.com** and proceed with the steps detailed in the "Registration Rules" to officially confirm this
- b. To officially confirm the participation, it is mandatory to make a first payment per team of 500€ in case of choosing "Option 1" with accommodation; or 250€ in case of choosing "Option 2" without accommodation.

This amount will be part of the total and will be deducted from the final payment.

c. The organization will not book spots without having received the corresponding registration and payment.

9. PRICES

a. PLAYERS, STAFF and SUPPORTERS / Option 1

280€ / person. Participation with full board accommodation and transport from hotel to the courts.

Entry on Thursday April 9th with lunch. Exit on Sunday April 12th with breakfast.

b. PLAYERS AND STAFF / Option 2

85€ / player. Coach free. Participation without accommodation or transport.

10. PAYMENT DATES

Pack confirmation must follow rules and established deadlines by the organization. We highly recommend confirming as soon as possible as we have limited spots.

a. Confirmation & 1st Payment - 500€ with accommodation / 250€ without accommodation – With team's confirmation.

We highly recommend making the first payment as soon as possible, as spots are limited spots and only the first to do will participate.

b. 2nd Payment - 100% of the amount - Before March 20th, 2019

It must be confirmed the total amount of people coming and the total payment.

Breach of deadlines amounts, and schedules can increase 15% on the final amount of the package.

The organization reserves the right of admission and can cancel the participation of any participant or team if they do not accomplish the established rules.

11. MAIN SCHEDULES

The organisation will inform the team about rules and standards to follow for a proper functioning.

a. Before January 1st

Inform about the whole amount of people coming (Players, staff and supporters).



b. Before March 6th

- Confirm the exact amount of people coming (players, staff and supporters).
- Confirm the arrival and departure details (airport, flights, schedules, etc.).

c. Before March 15th

Team must register all details related to the participants (names, dates of birth, flight details, uniform kit colour, medical insurance, etc.)

d. Before March 20th

The team must confirm 'MY TEAM' file with all information requested.

All participants who register from March 20th, must be confirmed by the organization. The acceptance of this participants will mean an increase of 15% on the applied rate.

12. ACCOMMODATION

Accommodation is in full board. The first meal included will be lunch, and last meal will be breakfast.

The rooming for the players and staff will be determined by the organization **15 days before** the start of the tournament. Meanwhile, the team will have to confirm and send the rooming for the supporters following the regulations of the tournament.

Each age class will have an assigned accommodation area fixed by the organization that must be respected.

The use of single room has a supplement of 47€ per room per day.

13. EXTRA NIGHTS

For teams that arrive or leave days away from the tournament, the organization gives support to manage accommodation, transportation, excursions, clinics, friendly games, etc. (more information at info@micbasketball.com or at +34 93 589 70 20).

14. TRANSPORT

Included only in the options with accommodation and competition transport.

You can apply for a transport service at the arrival or check-out, with an extra cost depending on the route.

15. GAMES

All the accommodated teams will have shared buses to go to courts in which they play matches, all of them will be controlled.

16. DOCUMENTATION

It is mandatory to deliver the following information to the organization on the fixed dates and before the start of the competition.

- a. Parental authorization and image rights of each player, that is generated within team web space (One copy for each player).
- b. All teams must send a copy by email and deliver signed and stamped the original consent file as they have medical insurance or otherwise wish to take out the insurance offered by the organization.
- c. Before team's arrival, team responsible must confirm in the scheduled dates imposed by the organization the document "MY TEAM", which reflects all the information about the team and hired services.
- d. "MY TEAM" file will be reviewed and confirmed upon arrival of the team. Any change not



authorized by the organization or reflected in it will be responsibility of the team and if there is any additional cost, the team will be the only responsible for it.

*All documents will be generated automatically in the web space or provided by the organization.

17. CANCEL AND REFUND POLICY

You have the right to cancel your registration at the tournament along the 14 natural days just after the date of registration. To that end you must let us know by hand, so we attach a desisting form at the end of these conditions, despite its use is not obligatory. This communication will be valid provided that it is sent within time period, and it will not be necessary that you indicate the reason why you desist, and any payment made until that moment will be totally refunded within the period of 14 natural days since the reception of your communication.

Each cancellation case will be evaluated by the organization. Any case not detailed will be considered as unique and the organization will inform team responsible. We will decide depending on the following points:

TEAM'S CANCELLATION*

- a. Cancel the participation before December 15th, 2019, we will return 50% of first payment. If there are more payments than the first one, we will give all the money back.
- b. Cancel the participation between December 15th and January 15th, 2020, will mean the loss of the entire first payment and only 80% of the rest of the payments that have been made will be refunded.
- c. Cancel the participation between January 15th and February 15th, 2020, will mean the loss of the whole first payment amount and only 40% of the rest of the payments that have been made later will be refunded.
- d. No refunds will be made for cancellations as of February 15th.

PLAYER'S CANCELLATION*

Total registration of participants must be made before March 20th, 2019. The refund policy for participants will be applied after that date and based on the following rules:

- a. Before February 15th we will refund 80% of participant's fee.
- b. Between February 15th and March 15th, we will refund 20% of participant's fee.
- c. After March 15th, will be lost the entire amount entered.

REFUNDS

Each case will be evaluated by the organization. Refunds will be made as it is detailed in the refunds policy and they will be made, in the assumption of the exercise of desisting in 14 days, during the following 14 days, from May 6th, 2020. In the latter case, the transfer costs are borne by the involved party.

*All cancellations must be followed by an official file stating the reason for this.

18. INSURANCE

All teams must have insured all team members, both on and off the field. The organization is not responsible for any accident that may occur during the Stage PRE-MIC and the tournament, or possible illnesses, thefts, etc.



The organization provides the option of hiring accident insurance (check prices).

19. TOURNAMENT CANCELLATION FOR FORCE MAJEURE

If the tournament must be cancelled due to major causes that exceed the control of the organizers or situations that cannot be attributed to negligence on the part of the organization, they cannot be accused of damages, costs or losses, caused as transport costs, accommodation, economic losses, etc.

In this case, the organization of the tournament reserves the right to retain the full fee and use it for a future tournament, or to refund those involved, once the expenses incurred by the organization of the tournament with third parties have been deducted. They cannot be recovered.

20. NON - COMPLIANCE

The breach of any of the established rules in this file or imposed by the organization, will be enough reason to cancel the participation of participants or teams.
